

## Official Rules Of The Dad Of Honor Contest

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

### 1. HOW TO ENTER

- a. These rules govern the Dad of Honor Contest promotion (the “Promotion”) being conducted by Makefield Putters beginning at 12:01 am Eastern Time (“ET”) on May 26th, 2024 and ending at approximately 11:59 PM ET on June 16th, 2024.
- b. To participate in the Promotion, you may enter via the following methods:
  - i. Beginning on May 29<sup>th</sup> 2024 at 12:01 am ET, log onto [thegolfshopshow.com](http://thegolfshopshow.com). All entries must be received by June 16<sup>th</sup>, 2024 at 11:59 pm ET. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. All entries submitted become the sole property of GSR. and will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by The Golf Shop Radio Show. The Golf Shop Radio Show computer is the official time keeping device for the Promotion. The Golf Shop Radio Show is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems.
  - ii. To participate in the Promotion, you may enter via the following method: log onto [thegolfshopshow.com](http://thegolfshopshow.com), Click on the Dad Of Honor giveaway on site and complete an official entry form including your first name and last name, complete address, city, state, zip code, home telephone number, date of birth, and valid email address. All entries must be received by June 16<sup>th</sup> at 11:59 pm ET.
  - iii. All entries are the property of The Golf Shop Radio Show and may be used for contact purposes from The Golf Shop Radio Show

### 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older. Employees of The Golf Shop Radio Show, its licensee, the licensee's parent, subsidiary and affiliated entities, advertising and promotional agencies, its participating sponsors, the members of their immediate families (spouse, parent, sibling or child) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Only one (1) winner in the Dad Of Honor promotion.
- c. The winner must provide valid government-issued photo identification and provide their complete address, date of birth and phone number to claim a prize.

The Golf Shop Radio Show will disqualify any entry from individuals who do not meet the eligibility requirements. The Golf Shop Radio Show will also delete any entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

- b. One (1) winner will be selected during the promotion in a random drawing of all eligible online and onsite entries received.

- d. If winner does not respond within 48 hours of drawing the winner forfeits the prize and an alternate winner will be selected.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release the day of the event.

## 5. CONDITIONS

By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
